VII. Treasurer’s Report (Dan Bergeron)

- a. Income
 - i. Raised \$10,394 from Cherrydale Fundraiser
 - ii. Raised \$2,855 from Spirit Wear sales to date
 - iii. Raised \$2,462 from Dine-Outs to date
- b. Expenses: Tracking well to break even or make a small profit
- c. Budget Requests
 - i. Ms. Knoles replaced Mrs. Styczynski November 2024 and is requesting \$200 allotment
 Gina Hollens motioned to approve
 Beth Jones seconded
 All in favor; unanimous vote
- d. This year’s fundraising projects
 - i. Shade on the blacktop!
 - 1. Start with permanent umbrellas installed over lower grade play structure with hopes to eventually install large umbrellas in open space
 - 2. Measurements completed. Official quote pending; ~\$16,500 estimated cost.
 - ii. New marquee
 - 1. Current marquee has large space for school name and logo with single line for announcements; wanting to replace with one that allows for multiple lines of announcements (4’x7’)
 - 2. Current marquee has been in place >10 years, past warranty
 - 3. ~\$16,500 estimated cost
 Leah Pereyra motioned to approve new marquee
 Janna Fischer seconded
 All in favor; unanimous vote

VIII. Open Discussion

- a. Parent Tammy Karcher discussed PTC Scholarship Funding Proposal
 - i. Not all FFE families are in a financial position to be able to pay for all school events
 - ii. Proposal for PTC to create scholarship fund for those with financial hardship (similar to what is already in process for field trips) [suggested \$2000]
 - iii. Would require an application process; other details still TBD
 Kym Torres motioned to approve
 Gina Hollens seconded
 All in favor; unanimous vote
- b. Parent Charisse Vivar inquired about Family Picnic
 - i. Date pending
 - ii. Ways to support and volunteer still TBD
